Held") are committed to protecting human rights by preventing modern slavery and human trafficking in our business activities with our service providers. We are a value-driven organization with a zero-tolerance attitude towards slavery and trafficking of any kind. We expect our stakeholders, including our service providers and suppliers, to comply with our values and to have appropriate policies and procedures in place to ensure that slavery and human trafficking do not exist as part of any operations.

Our Business

J.S. Held is a global consulting firm specializing in technical, scientific, financial, and strategic advisory services. Our professionals operate across continents, assisting clients in navigating complex challenges and mitigating risks. We acknowledge the potential for modern slavery within our global network and are steadfast in our commitment to upholding the highest ethical standards throughout our operations and supply chains.

Our Policies

J.S. Held has a zero-tolerance policy towards modern slavery and human trafficking. We are dedicated to ensuring that our operations and supply chains are free from any form of exploitation. We have implemented the following policies to prevent modern slavery and human trafficking:

Due Diligence Process

Our third-party contracts include clauses that mandate compliance with all applicable laws including labor laws and human rights standards.

Risk Assessments & Management

We are cognizant that certain sectors and geographical regions within our global operations and supply chains may carry an inherent risk of modern slavery. To proactively address these challenges, we implement a comprehensive risk management approach that includes:

- Risk Mapping: We regularly conduct risk assessments to pinpoint areas within our operations and supply chains susceptible to modern slavery. This involves evaluating factors such as geographical location, industry sector, and labor practices.
- **Targeted Due Diligence**: We employ enhanced due diligence measures for high-risk suppliers and regions, including audits, independent third-party verification, and ongoing monitoring.
- **Collaborative Engagement**: We actively engage with suppliers, industry associations, and NGOs to promote transparency, share best practices, and collectively combat modern slavery risks.



Performance Evaluation

We measure and analyze a range of key performance indicators (KPIs) to ensure we are combating modern slavery. These KPIs include:

- **Supplier Audits**: We conduct regular audits of our suppliers to assess their compliance with our Third-Party Code of Conduct and identify any potential risks or violations.
